## A FUTURE WHERE NO FAMILY IS HOMELESS IN PIERCE COUNTY

Families are sleeping on the streets, in their cars or living in shelters. Our community must meet the immediate need of housing in order for families to achieve self-sufficiency.

Our Family Permanent Housing program is strengths-based and family-driven, because when a family takes ownership of the work being done they are committed to their action steps.

We walk alongside our families to get them off the streets and into a rental property within the first 30 days of entering the program. We provide rent assistance while the family works with a case manager on personalized family goals. These goals may include education, employment or increasing natural support systems. Each family is given access

to community resources, guidance on increasing mainstream benefits eligibility, employment and education services and more.

## PAINTING TACOMA BEAUTIFUL



Ray Carreau has seen a lot in his 95 years. He served in the Army, Merchant Marine and Coast Guard and was present at the invasion of Normandy. This past fall he witnessed the love and kindness of strangers who painted his home and replaced his leaky windows through Paint Tacoma-Pierce Beautiful (PTPB).

The white paint covering Ray's house was flaking badly.

Living mostly on Social Security, Ray didn't have the means or physical ability to maintain the property as he did in the past.

Of the 26 homes chosen for the Paint Tacoma Beautiful program this year, six belonged to veterans like Ray. A crew of volunteers — including members of the 16th Combat Aviation Brigade from JBLM, students from the Youth Build program and retired Air Force airman Mike Farley — showed up and got to work.

"It's really about building community. It's not just the homes that get painted, but connections among neighbors and community groups are forged," said Amy Allison, Director of PTPB.

For volunteer Mike Farley, the work felt unfinished even when Ray's house had a fresh coat of paint. He noticed the windows were old, single paned and not weatherized. He contacted Puget Sound Window and Door and the company agreed to replace all of the windows free of charge. "My generation was just in awe of these guys; they stepped on up, and just accepted it as what they had to do. Getting to know Ray, and to do something for him, it's an honor for me," said Mike. ☺



## INTERFAITH WOMEN'S CONFERENCE

This past spring, over 400 women attended AM's Interfaith Women's Conference, "Building Bridges of Interfaith Unity". With more than 24 speakers offering workshops, 50 vendor booths,

yoga, meditation and sacred spaces, this conference had something for everyone. The conference's focus? Listening, dialogue and action. Planning is underway for the 2nd biennial conference, which will be held on March 9, 2019. 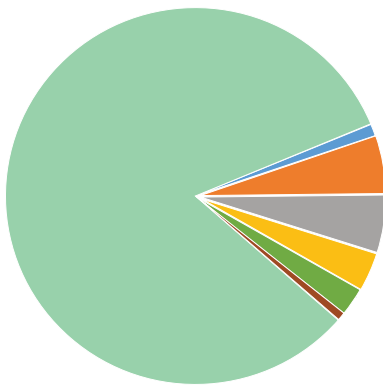

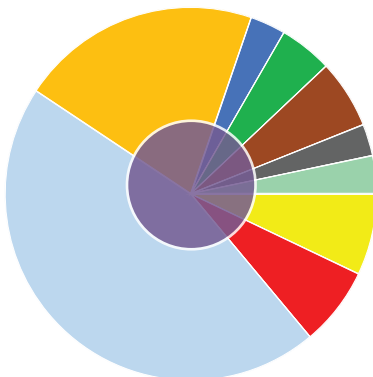
